The Season at a Glance: BOYS' GAMES ARE PLAYED ON SUNDAYS, & PRACTICES ARE DURING THE WEEK, NOT ON FRIDAY OR SATURDAY. The girls play games on Saturdays. All games are played at local area gyms, with locations varying by division. The season begins on November 12th and 13th with player evaluations at Weber and Niles North High School. Evaluations and practice continue in November, with practice games in December. (Player evaluation schedule will be posted on quick scores website. Regular season games begin on January 7 and 8 and end in mid-March. 4th thru 8th grade teams have one weeknight practice per week. Younger divisions have short practices immediately prior to the weekend games.
